Pursuant to the Freedom of Information Act, I hereby request the following records:

To whom it may concern,

My name is Dr. Andrew Huff, and I am working with the House Select Committee on Intelligence with Mr. Ravi Batra, Ravi Batra Law, related to the investigation into the origin of COVID.
